Key Advocate Aurora Health Action Items

- Hope is finding a way through these challenging times. Advocate Aurora Health doctors, nurses and team members cheered several COVID-19 patients as they were discharged from our hospitals across Illinois and Wisconsin. The health system surpassed its 1,500th COVID-19 patient discharge and you can find several inspiring stories on our social media channels.
- We are extending existing restrictions on elective surgeries, procedures and non-urgent ambulatory visits through May 1. We will continue to reassess these restrictions on a weekly basis.
- We're encouraged to see the curve is leveling, yet we remain vigilant in our efforts to continue to stem the spread while adjusting our response tactics based on the evolving needs of the patients and communities we serve. As such, we will be closing most of our Emergency Room overflow tents based on current and projected volumes so we can redirect our resources to areas of greater need. Patients with severe COVID-19 symptoms will continue to go to the Emergency Room to determine if testing and admission is required. Patients with mild COVID-19 symptoms will be directed to modified immediate care/urgent care sites designated to care only for patients who present with COVID-19 symptoms. Nearby immediate care/urgent care sites are designated to treat only those patients without COVID-19 symptoms. This model allows us to provide the right level of care in the right setting for both COVID-19 and non-COVID-19 patients to keep them and our teams safe while effectively managing our resources, including limited PPE and testing.
- Through the diligent efforts of Supply Chain to continue to keep our team members and patients safe, all team members will be provided exam masks as part of our universal masking policy, which provide a level of personal protection with fluid resistance and filtration efficiency. Our supply chain team continues to focus relentlessly on securing additional PPE through all trusted, reliable sources.
- We continue to update our policies and have extended our no-visitor policy with limited exceptions.
 During the no-visitor policy, we will ensure patients can connect to families and loved ones virtually using their personal devices and free technologies. For patients who do not have access to their own device, we have devices that can be used to help facilitate a virtual visit with the patient and their family.

- As a trusted health care partner, Advocate Aurora is committed to keeping our patients and consumers informed about our response to COVID-19. As a reminder, we continually update the COVID-19 Resource Center and our social media channels with relevant and helpful information, tools and resources.
- Our online COVID-19 Symptom Checker is the best way for patients to find the care they need. By answering a few simple questions, they'll quickly learn what they need to do next from seeing a provider with a video visit 24/7 to contacting their doctor.
- The COVID-19 hotline at 1-866-4-HEALTH is staffed by clinicians who can answer questions about symptoms and determine the next steps in care.
- Our Virtual Health platform, <u>LiveWell app</u>, continues to offer virtual appointments with physicians 24-hours a day. Those who have or suspect they may have COVID-19 symptoms can do a virtual visit.

- We are seeking convalescent plasma donations from patients who have recovered from COVID-19 to help patients with severe COVID-19 symptoms. Recovered patients have antibodies within their plasma that can attack the virus and potentially help our sickest patients. Historically, plasma has been used when new diseases or infections develop quickly, when no other options are available. We are partnering with Versiti Blood Center of Wisconsin to refer our COVID-19 recovered patients for plasma collection and are also partnering with the American Red Cross in Illinois, but they do not yet have their plasma collection sites operational in Chicagoland.
